
Properties can be let if they have an energy rating from A to E.

## **Energy efficiency rating for this property**

Properties are given a rating from A (most efficient) to G (least efficient).

Properties are also given a score. The higher the number the lower your fuel bills are likely to be.

| 1. Increase loft insulation to 270 mm   | £100 - £350               | £48                   |
| 2. Internal or external wall insulation | £4,000 - £14,000          | £482                  |
| 3. Heating controls (room thermostat)   | £350 - £450               | £57                   |
| 4. Condensing boiler                    | £2,200 - £3,000           | £97                   |
